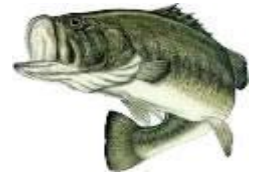

In signing this form and paying my fee, I hereby agree to waive and release, the hosts, sponsors, and tournament officials harmless from any and all claims of death, injury, and/or damage incurred in connection with this tournament. I further understand and agree to abide by the rules of this tournament, all state regulations associated with fishing on the body of water this tournament is held, and recognize the rights of the tournament officials to reject any entry. Boat and towing vehicle insurance is required to participate.

All tournaments are \$125 per team which includes the Big Bass Pot. Partners/teams can be substituted (see rules for special qualifications for the September Tourney) but no refunds. Number of places paid is based on number of boats. \$15 from each entry fee will be reserved and added to the purse for the Circuit Finale less DNR permit fees, which is the September Tourney. Tournaments have 19-boat/team max; first registered and paid, first in. Registration for the 2021 tourneys opens to the public on Monday, 4 January 2021 at Hayward Bait and will continue until the tourneys are full or at 5pm on the Friday before the individual event—whichever comes first. Launch order numbers will be drawn live on Facebook when registration closes. Cash entries for any unfilled slots will be accepted at the ramps. May and September Tournaments are from 8am to 4pm, June, July, & August tournaments are from 7am to 3pm. Pre-tournament Meetings 15 minutes prior to take off.
